**Dr Maurice L Newman AC, HonDBus Macq, FSIA, FSAA, FAICD**  
 Maurice Newman AC is the former Chairman of Deutsche Bank Australia & New Zealand, Australian Securities Exchange (ASX), and Australian Broadcasting Corporation, and Chancellor of Macquarie University. His career spans over 50 years in stockbroking and investment banking. Dr Newman has chaired a number of Asian business alliances and has been an adviser to Australian governments, State and Federal. Dr Newman is currently Chairman of Melon Pastoral Pty Ltd; M Value Capital Advisory Board; Chamber of Australia-India Trade & Investment (CAITI); Macquarie University Foundation; Taronga Foundation; Bradman Foundation; and The Australian Fathers’ Day Council. He is a Director of O’Connell Street Associates Pty Limited; Senior Corporate Advisor to the Marsh & McLennan Companies; Trustee, Sydney Cricket & Sports Ground Trust; Member of the ADC Advisory Council; Member, Advisory Council Advance Australia; Member, CEDA Leadership Council; and Honorary Life Trustee of CEDA. He was appointed Chairman of the Prime Minister’s Business Advisory Council in 2013; and Honorary Professor in Public Diplomacy at the Soft Power Advocacy & Research Centre, Macquarie University in September 2012.



**The Hon Judge Richard Weinstein SC, District Court of NSW.**  
 Richard Weinstein SC was appointed to the District Court of New South Wales in December 2018. As a barrister he had wide experience in a range of areas including, professional negligence, wills and probate, disciplinary proceedings and alternative dispute resolution. He took silk in 2011. He is an Adjunct Professor at the Law School of the University of New South Wales where he has lectured in the law of evidence since 2010. He is the lead author of

Uniform Evidence Law in Australia, to be published early next year. In September 2017, he was appointed as Advocate for Change by former NSW Bar Association President Arthur Moses SC to continue his efforts in formulating “strategies to promote equality, diversity and inclusion”. Judge Weinstein was at the forefront of advocating for diversity at the Bar for many years, including the inclusion of LGBTQI+ people.



**Mr Philip Truskett AM, MB BS FRACS FACS FASGBI (Hon) FAICD FRCSEd (ad hominem)** Phil Truskett is a General Surgeon with an interest in Upper GI and HPB Surgery at the Prince of Wales Hospital, Sydney, where he is a senior staff specialist. He has taken an active role in both the Royal Australasian College of Surgeons and General Surgeons Australia. He is a past President of General Surgeons Australia. As a College councillor he has served on many College committees. He was the Chair of the Board of

Surgical Education and Training and then served as Censor in Chief. He is a past President of the Royal Australasian College of Surgeons. He is the current Chair of the Council of Presidents of Medical Colleges (CPMC) and current Chair of Day Hospitals Australia (DHA). His major interest is in the provision of Emergency Surgery to our community in our current challenging environment. As a result, he has been involved in the design and assessment of models of care to provide consultant-led timely care. These models of care are now being adopted in Australia and New Zealand. He is a strong advocate for sustainable surgical service and professionalism. “The provision of patient-centred care in a safe, clinical environment is the benchmark by which we are all judged as professionals and how we should judge one another. It is education in the non-technical skills of surgery which will strengthen our place in the community.” This education is a current focus. He is a proud patron of the Australian Indigenous Doctors Association and a committed advocate for equity of access for indigenous Australians to medical schools and specialty training.
