Ms Rachel King began studying the multidisciplinary field of neuroscience from a need to know basis, with a focus on how the brain learns and adapts, known as neuroplasticity. Her work ranges from educating about the neurobiology of stress and its impacts on mental capital and wellbeing to translating case specific complex neuroscientific evidence to advising organisations such as Cochlear Ltd and guest lecturing at Macquarie University.
